#### COLLECTION AND USE OF INFORMATION

<u>No Account Needed</u>. The Nature Passport App does not involve creating an account or collecting any data or information that can be used to identify you (or your authorized child) (together, "**Personal Data**").

Information Related to Use of the Services. Our servers automatically record certain information about how a person uses our Services (we refer to this information as "Log Data"). Log Data may include information such as browser type, operating system, the web page that a User was visiting before accessing our Services, the pages or features of our Services to which a User browsed and the time spent on those pages or features, search terms, the links on our Services that a User clicked on, and other statistics. We use Log Data to administer the Services and we analyze (and may engage third parties to analyze) Log Data to improve, customize, and enhance our Services by expanding their features and functionality and tailoring them to our Users' needs and preferences. We may use a person's Log Data and other information to generate aggregate, non- identifying information about how our Services are used and use such aggregated information to understand and improve our Services and to administer use of the Services.

<u>Information Sent by Your Mobile Device</u>. We collect certain information that your (or your authorized child's) mobile device sends when you (or your authorized child) use our Services, like a device identifier, user settings, and the operating system of your (or your authorized child's) device, as well as information about your use of our Services while using the mobile device. We may use this information to provide the Services and to improve and personalize our Services for you (or your authorized child).

We will not share any information that we have collected from or regarding you (or your authorized child) except as described below:

<u>Information Shared with Third Parties</u>. We may share aggregated information and non-identifying information with third parties for research and analysis, demographic profiling, and other similar purposes.

<u>Information Disclosed for Our Protection and the Protection of Others</u>. We cooperate with government and law enforcement officials or private parties to enforce and comply with the law. We may disclose any information about you (or your authorized child) that is in our possession or control to government or law enforcement officials or private parties as we, in our sole discretion, believe necessary or appropriate: (a) to respond to claims, legal process (including subpoenas); (b) to protect our property, rights, and safety and the property, rights, and safety of a third party or the public in general; and (c) to identify and stop any activity that we consider illegal, unethical, or legally actionable activity.
